Abbott House Child Advocacy Center is seeking a Family Advocate to provide victim support to children and their non-offending caregiver.

The Role of the Family Advocate

- Act as a family advocate for the child victim and their non-offending caregiver, including contact
 before, during, and after visits to Abbott House. This includes, but is not limited to welcoming and
 orienting families upon arrival; providing support and care for children during their visit; providing
 information and support to caregiver during the forensic interview; meeting with family for a needs
 assessment and referral consultation; assisting family in locating services for counseling, medical
 care, and basic needs; coordinating with appropriate individuals and agencies as needed.
- Serve as family liaison with investigative and multidisciplinary team members, networking and linking with other social service agencies that provide needed services.
- Handle confidential information with tact, discretion, and in compliance with job requirements.
- Attend staffing meetings for cases to gather information about the referral needs of each client and family.
- Attend bi-weekly case reviews and communicate case updates to the MDT team.
- Enter case information into NCATrak and personal logs in a timely manner.
- Assist with volunteer and intern programs, including training and scheduling.
- Maintain professional and technical knowledge by attending educational workshops and reviewing professional publications.
- Be knowledgeable of our Safety in Action Program and alrt! and assist with community presentations after hours as needed.
- All other duties assigned by the Executive Director.

Our Mission

Abbott House opened its doors in 1996 using borrowed space and operating with a part-time staff of one. Today, Abbott House employs eleven full-time and two part-time staff and offers four robust programs under the roof of a 7,500 sq. ft. building. Since its inception 27 years ago, Abbott House has served more 23,800 children in central Oklahoma.

Our mission is preventing abuse, advocating for children and fostering hope and healing. We fulfill our mission through through four areas of programming, forensic interview, advocacy, medical assessments and educational outreach. As a nationally accredited child advocacy center it is our goal to provide a trauma informed, child-friendly environment where multidisciplinary team members work together to reduce the re-victimization of the child, remove barriers to investigation and treatment, and provide referrals that will set children and their non-offending caregivers on the path to healing. Abbott House also seeks to educate the general public on recognizing and reporting child abuse.
